
Tayana: win, place, show! FAR NIENTE Reports on the Caribbean 1500

The Caribbean 1500 is an annual rally from Norfolk, VA to Charlotte Amalie, St. Thomas U.S.V.I. for sailors to passage offshore safely in company with other passagemakers Dan and Suzy Reidel felt this was an effective way to get their new T-48 to the Caribbean. Their report follows.

Our Tayana 48, *FAR NIENTE* (hull #32) was finished as scheduled (mostly) and entered the Annapolis Boat Show on 3 October 1994. We were finishing the backstay insulators up the mast as we motored into the slip for the show. The show was fun, but it was areal strain knowing that we still had so much work to do in preparation for the Caribbean 1500. Passport Yachts took over the importing of Tayana in the middle of all this; they are nice people and will do the company proud.

FAR NIENTE's maiden voyage began much like we entered the show. We literally had a line of friends throwing our gear into the salon so we could meet the deadline for our next adventure. We left the dockyard at 7:00 p.m. on Thursday, 13 October, for the 140 mile trip down the Chesapeake Bay in the dead of night. Exhausted and blearyeyed, we had a near encounter with an unmarked buoy, which left us extremely alert, and arrived unscathed in Hampton, VA the following morning. The

next week was equally hectic, with offshore classes, briefings, provisioning, and boat inspections to bring the boat up to Category I offshore safety standards and the strict requirements of the Caribbean 1500.

The Rally (race) started 22 October from Norfolk, VA to St. Thomas, USVI. The first day was extremely calm and we elected to go south initially, although most of the fleet of 60 boats went east (the traditional wisdom). By midday the following day we made the edge of the Gulf Stream in the teeth of a 45 knot gale, 15' to 20' seas, wind, spray, white water in the cockpit, and more noise than you can imagine. We shortened to our staysail and 1/3 of our main (the stoaway main was great) and sailed through it, averaging above 8 knots. Half of the fleet hove to, but we carried on. Our autopilot didn't work for the first three days, until we discovered Suzy stored a spare pump within six inches of the fluxgate compass.



When the storm was spent (and crew too), we were well beyond the Gulf Stream and much further south than the rest of the fleet. The boat took the gale like a pro, but the rig was badly beat up; we lost all the partners (the wedges that keep the mast in place), a running backstay, and blew out a main traveler block. We almost diverted to Bermuda, but decided against that when another storm was reported bearing down there. Two days later we encountered a second storm, but it was nothing compared to the first one. The daily weather advisories and network reports from the Caribbean 1500 fleet were very helpful in avoiding other weather systems in our path.

The balance of the trip was, for the most part, a fun trip. We sailed the rhumb line to St. Thomas and made two 200-mile days with strong winds on a close reach. We flew our new spinnaker for about 24 hours on one run and caught four fish, landed two and ate one (36" mahi-mahi). We saw more stars than we could every imagine (remember the milky way?). Schools of dolphins visited us twice, so close you could almost touch them. And, although it was so calm one afternoon that Suzy wanted to go swimming, the crew wouldn't stop the boat--we were, after all, in a race! We arrived in St. Thomas in eight days and 22 hours. FAR NIENTE finished 3rd out of 60 boats, behind a Tayana 55, BOUTONNIERE, and a Tayana 52, SOJOURNER. Not bad for a green boat and a green crew (real green through the Gulf Stream). It is a credit to Tayana, that the first three boats to finish were Tayanas.

The following week in Crown Bay Marina in St. Thomas was spent in rebuilding, recovering, and drying out the boat. We probably put the equivalent of three years of use on the boat in one week, but we're confident of the boat and feel that it's now a proper yacht, fully tested and ready for anything (forget the 45 knot gales, thank you very much). *FAR NIENTE* is currently berthed in Nanny Cay on Tortola, BVI, awaiting her next adventure.

We spentmost of our time during the summer, not sailing, but outfitting and upgrading. The list of items was long, and included anew (Switlick) liferaft, SSB radio with new insulated backstay for an antenna, windlass, Monitor wind vane, GPS, PC software including chart plotting (The Cap'n), new batteries and battery boxes, Heart Interface, storm sails, and a new alternator. As we worked to prepare to leave, we enjoyed the prospect of not needing to go through the ritual of winterizing and hauling SYMPHONY this year.

"As we thought we were coming close to the end of installing equipment and fastening everything down, we started to load charts, books, clothing, et cetera for setting out. However, it was not to be, at least not just yet. On 5 October, SYMPHONY, along with four other boats was struck by an errant fuel barge while at her regular mooring. She has sustained some sprung bulkheads and significant external damage along the port side. The bowsprit that we repaired, expoxied, and varnished so carefully last winter will have to be replaced. Fortunately everything is repairable, but it will take some time. The yard advised us that it will be sometime in January before the repairs can be completed. Whether it will be possible at that time to recommission her and sail south, and whether it will seem to us that we want to make the voyage in February, is doubtful. We think we will abandon for now the thoughts of warm, clear, blue water and continue with our plan to sail to England in May directly from New York.



A friend copied past issues of *TOG News* for us and we found it to be very enjoyable and informative. We would like to become members."

Phil and Teresa Patterson sold *LEPAS* (T-37, hull #246) last March. "We really had no particular intention of selling her.... However, during the summer and fall of 1993, we continued to look at V-42, T-47/48, etc., as we felt the family size warranted a bit larger vessel....On a business trip to

Boston in October 1993, I decided to take a couple of days and visit Acadia National Park. Lots of boats coming out for the winter....On a chance that I might find something, I called a friend at Bass Harbor, ME. Lo and behold, in their storage building, out of water since its 3-week maiden sail in 1991, was ... a Tashiba 40, teak decks, Furano Radar, Sea Frost, Northstar Loran, etc....Our friends at Bass Harbor related that I was one of the few, if not the only prospect who had come to inspect the boat. Knowing the owners perferred to sell before spring '94, (they had paid storage through this time), we made an embarrassingly low offer. The rest is history. We then advised our broker to market LEPAS. We had several lookers, a couple of deposits, and in March a buyer. We released our slip in Annapolis, MD, and have decided to leave the Baba in Maine for the next two seasons. Missing the TOG Rendezvous on the Bay left us feeling that our year contained some holes. The TOGers are really a great group! Due to the vast amount of information in my TOG newsletters, I kept them for their reference value. We intend to remain subscribers, and, if the group wouldn't mind, we would enjoy attending the rendezvous when we return to the bay area in 1996 or 1997 after a couple of seasons exploring the Maine coast."

Mike Rose writes from Seattle, "I have recently purchased a Tayana 42, after having owned a Tayana 37 for a number of years. A radical move to be sure. One my wife and I are both very happy with, I might add. I purchased the vessel, *PACIFIC GRACE* (hull #168), in Newport Beach, CA and recently sailed it to Astoria, OR, where she now lays. The trip was more than I had bargained for, as we encountered two major gales enroute and had to have the Coast Guard helicopter come to our assistance when we were down to our last fuel filter in the middle of one of the gales. He guided us to a safe anchorage on the California coast new Cape Mendocino, where we stayed for two days until the storm blew itself through. I learned more about this boat in the



18 days it took to get to Astoria than I knew about my previous Tayana after five years of ownership.

"We plan on leaving next summer on an extended cruise and I can say that I feel quite comfortable in the knowledge that I will be leaving on a sound vessel capable of weathering some fairly severe weather." (See Mike's comments on Fuel Filters in the Maintenance section, p. 39)

Maintenance and equipment comments and questions...

BOBSTAY FITTING

Richard Bennett says, "it's not the big things that bring progress to a screaching halt, it's all the little stuff, like nuts and bolts. When replacing the old bobstay fitting on PANGAEA (T-37, hull #474) the slot-headed bolts had to be removed by using a hand-held impact wrench and vise-grips. Since the old bolts were corroded, they had to be replaced. The vise-grips had damaged the heads so there was no way to refurbish them. The bolts were not American threads, nor were they metric, but an obsolete sort "British Standard Whitworth", which disappeared about 35 year ago, except in Taiwan (They are in the pedestal, too.) The only steel suitable for that wet location is stainless steel, grade 316 and none are available in BSW threads in the United States. An appeal to Scottish Imports/British Metric (1-800-762-5134) found that none were available in the U.K. either, but they sent me a die and die handle, which solved the problem (1/2" W-12). American hex head SS 316 bolts aren't easy to find either, but a wholesaler in Miami drove to his home in Fort Lauderdale for me with the only two bolts he could find. The American threads were cut off and new BSW-12 threads cut. A BSW-12 tap cleared the threads in the plate embedded deep in the bow when galling occurred. I heard that some boatyards simply re-tap this plate with American threads, but I felt that if I had messed up that plate, there would be no way to recover the situtation. As recommended by Nigel Warren in his book, Metal Corrosion in Boats, the new bobstay fitting was welded up of SS 316L (low carbon content) to prevent weld decay corrosion. The book has a wealth of information useful to boaters."

OVERHEAD LIGHT LENS

"The little screws that hold the glass lens on the overhead lights are American threads #6 diameter—32 threads per inch and are 1/4' long with small heads with Phillips slots. If these exist in chrome plated brass it would be easy to cut them short, but the shortest available are 3/8" long, and stainless screws are too hard for the screw cutter on my solderless connector crimper. Since there are six per light, the loss of one is of no physical consequence, but I notice the empty hole."

FLEXIBLE COUPLING

"The safety-wired nuts and studs on the flexible cou-

pling had been hand drilled and matching these randomly spaced holes provide impossible. The nuts readily available were 10 mm threads with 1.5 pitch (coarse) and the threads on the coupling studs are 10 mm, 1.25 pitch. These are not common, but a small supply was obtained through a special order at Boat Owner's Warehouse [(305) 522-7998] in Fort Lauderdale, from The Metric Connection in Palm Beach Gardens, FL [(407) 743-4642]. Self-locking, nylon-insert nuts cost \$3.25 each, plus postage. These have been installed with loctite 242 added for additional security.

"Three different threads (BSW, metric, and SAE) have been covered. Now comes a no-threads, press-fitted spacer/ collar in the forward plate onto which the flexible coupling bolts. In the attempt to remove the propeller shaft, this spacer/ collar was loosened and fell into the follow center of the coupling where it made a great racket. It is a close fit, but not a tight fit, so it was pressed in place, plus a coating of loctite 271. A better choice would be loctite 680, which fills spaces up to .015 inches. Loctite 271 fills up to .007 inch, which was probably adequate. We shall see if it holds."

INTERIOR TEAK FINISH

Someone told John Hussey of *GALATEA* (V-42, hull # 119) they read that a good treatment for interior varnished teak was an application of the oil WD 40. We checked through all the old references in *TOGNews* and came up with Lemmon Oil as the most frequently used product. Has anyone had experience with any other product on their interior teak finish? Any heard of using WD40?

T-37 HOLDING TANKS

We have received a number of inquiries regarding location, size, fittings, and use of the holding tanks on the T-37. I'm sure there is a greater consideration given to holding tanks, certainly in the U.S., because there is a mandate that they be used anywhere but offshore. People who have had boats with tanks, and never used them except for spare water tanks, now must put them in use.

We talked with **Bob** Klein about the subject and he has offered some information, which he has learned about his tank. We suspect that since TaYang began installing them in the early eighties, they have all been installed in the same place in the sloop rig - under and toward the rear of the engine - molded in place. The yard says they are a 35 gallon tank, but Bob said that he and first mate, Marge put a measured 50 gallons in his tank. The tank has two penetrations, one an input hose, which can come from the head, and the other an output hose, which runs down inside to within an inch of the bottom of the tank. At the tank top, the output hose should have a "T" on it that will permit a suction on the tank from either the manual bilge pump, or from an external pump, as at a dockside pumpout station. The tank is vented to a small disk vent on the gunwale. Bob commented that when the head is pumped to the tank when one is entertaining in the cockpit, it could be embarrassing to those not associated with the sensual rigors of the cruising life!

If those rubber hoses are old and subjected to some stress or working, they could leak. It may be hard to tell; the hose connections at the top of the tank are very difficult to see. If one has an older boat and is planning to move the engine for any reason, replacing these hoses might be a job that should be considered, whether or not a problem has been indicated.


HARD DODGER

Mike and Yvonne Rose are making preparations to move aboard their vessel, *PACIFIC GRACE* (V-42, hull #168). "My wife has requested I explore the possibility of installing a `hard' dodger. I have been concerned that any retofitted dodger would look like an `add on' and would detract from the lines of the boat. I told her I would do it only if I could be assured that it could be done and still look nice. Perhaps there is someone who has had such a modification made and could share a photo or the plans used for making this addition." FUEL FILTER INSTALLATION

Mike Rose comments, "Bar crossings in Oregon/Washington waters are serious business. Many boats are put on the rocks or require assistance every year because of poor planning with regard to tides and currents and general rough bar conditions created by weather. I am always concerned that my engine will quit for some reason at the most inopportune time and place me in a crisis situation. For that reason, I always cross bars under power, but with sails deployed in order to give me that added advantage of an alternative method of maneuvering should the engine quit.

Because most engine failures are associated with fuel problems, I have taken steps to mitigate one common problem in that area, dirty fuel. I have installed an additional Racor unit and have plumbed it so that should one of the filters become clogged and quit, all I need do is switch an in-line valve, so fuel begins to flow through the clean filter. I can then change the dirty filter at my leisure. This has not only given me great peace of mind during bar crossings, but also during rough conditions at sea, when the motion has stirred up the sediment in the tanks resulting in a clogged filter. Being on your hands and knees in the bouncing boat changing fuel filters by flashlight is not enjoyable. Simply turning two valves is easy." (See Figure below)

TOG NEW!

After a year in Indonesia, Leanna and Jerry Spears returned to Bremerton, WA for 5 months of work on *TUM-BLEWEED* (T-37, hull #169) and left mid-August for Mexico, spending time in San Francisco and San Diego on the way.

David Waltz left Annapolis last Christmas cruising south on *VICTORIA* (T-37, hull #222). "I knew I wanted to visit Washington, NC, on the Pamlico River, for its history and proximity to the huge maritime history library at nearby East Carolina University. The problem is that aside from a small marina "downtown", the several marinas in Broad Creek seemed closed to a T-37, for the chart showed less than six feet of water in the whole of Broad Creek.

"Sailing up the river late on a Saturday afternoon, with a kaput echo-sounder, the sun in my face, and no local knowledge, I was about to anchor for the night at Bath, five miles from Washington. Two vessels were leaving Bath Creek at the time, and one looked very familiar—a Tayana 37! Barry Adams aboard *KAMA* (hull #14) showed me the way into Broad Creek in the failing light, and our two boats have been moored in adjacent slips since then. Barry has an excellent stock of tools and Tayana knowledge! Broad Creek is do-able in these boats, but be prepared to run aground. Like the Bay, it's just soft mud. Slip prices are one-third that of the Annapolis area.

"Getting to Washington is easy from the IntraCoastal Waterway (ICW). Hang aright (west) into the Pamlico River, just after leaving the Belhaven area. Broad Creek is about fifteen miles up, and pretty Bath Creek is about eight or ten off the ICW. Bath is an early capital of North Carolina. It is also a former hangout of Eddie Teach, the pirate who gave his nickname, "Blackbeard" to many cheap bars and restaurants in the area. It has high banks and deep water, a small state public dock, and a bed and breakfast on the water.

"In late October, *VICTORIA* will become a true cruising boat, leaving for the Bahamas and all points beyond. There will be four souls onboard: two humans and two dogs! The general plan is south Florida by Thanksgiving and Georgetown by Christmas. We will muk about in the Bahamas and then continue south and east through the Dominican Republic and Puerto Rico, etc. I would appreciate hearing of any recent experiences in thosewaters from other TOG people."
