### M aintenance Tips

#### **PARALLAX**

Good old boy Al Boyden, *Parallax* (T-37, hull 51) provides some answers to the often asked questions regarding replacement of cabinet hinges and portlight gaskets:

"If you have a good hardware store in your area, ask for SOSS Invisible Hinges or write to the manufacturer, Universal Industrial Products, 1 Coreway Drive, Pioneer, Ohio 43554-0628, phone (419) 737-2324.

From the Delta Rubber Co., 2648 Teepee Drive, Stockton, CA (zip?) (800) 692-3716 you can buy 3/8" round bunacord rubber at \$1.28 a foot. After cutting to the correct length, glue the ends together with super glue. Then use a silicon rubber

to hold it in place. As an alternate you can order 3/8" square cut which they will cut from a piece of flat neoprene.

In addition to the above, Al describes his experience having his anchor chain re-galvanized:

"I took 500 feet of 5/16 chain, which weighs 500 lbs., in to be galvanized. The chain now weighs 600 lbs, or 100 lbs. of zinc was added. They did a good job of removing the rust and found 8 or 9 spots and one link that did not get coated so they cleaned and painted these areas. The charge was 31 cents a pound."

Finally, Al tells us about a way around stuffed up chain locker drains

(see sketch):

"I found that the drain hole in the bottom of the chain locker was stuffed with sand after finding the mattress soaked. This drain hole exits at a level under the fuel tank and was unreachable. Holding my breath, I drilled a new hole in the locker bottom and discovered a cavity (see sketch),I then drilled another hole into the cavity at right angles to the first at tank top level and inserted a plastic elbow into the hole. Then I attached a length of hose to the elbow and led the hose to a convenient spot."


#### FAR AWAY

"To avoid a mess when changing oil filters I found that the filter fits nicely into a coffee can. When the plastic lid is snapped on, it is a fool proof method for avoiding oil spills."

Tom & Ann Bowers cruised *Macbee*, a T-37, from Newport, Oregon to the Canadian Gulf Islands last summer. Tom wrote, "Being retired, we can wait out the bad weather. As a consequence, we found the cruise up the coast a "piece of cake". It was somewhat bouncy going past the mouth of the Columbia, but not bad elsewhere. After leaving Port Angeles, Washington, we entered a different world. On the Pacific coast we could ignore tides and tidal current. But not so on inland

learned to plan our passages in conjunction with the tidal currents, We found that our Loran was a wellspring of important information. . We also learned to study the Canadian charts for location of tide rips and whirlpools.. For the most part the weather was great, except for fog. We found our Furuno model 1720 radar to be very helpful. For example, we were motoring across Rosario straight in a typical fog toward Thatcher Pass, which showed clearly on our radar screen. We heard the bellows of a big ferry approaching. We noted that it came past us at a much slower speed than usual. Then, as it passed, we saw the reason. It was closely followed by twelve power boats, none of which had radar! It reminded us of a mother duck with twelve ducklings."

#### JOSS

After spending the spring in Mallorca, Dick & Rachelle Miller cruised their T-37 *Joss* to the canals of France. They plan to spend the winter in Paris.

#### **AUF WIEDERSEHEN**

Don and Bev Rock sailed their T-37 to one of their favorite Philippine stopovers. Don writes:

"We were clipping along on a close reach when the forestay parted just at the point where the

enters the bottom of the Hood Seafurl drum. Picture a huge Yankee jib in 18-20 knots of breeze with the bow pitching in 2 meter seas, and on the end of the forestay a large furling drum flailing around like a wrecking ball. There were a few hectic moments. The drum was beating against the lifelines, the hull, and the cabin top until I turned the boat downwind and lassoed the loose end. I now believe that the Hood system has a design weakness in that one must cut the forestay and bury the cut end in a Norseman fitting which itself is buried inside the lower drum bearing housing. There is only 1/2" of threads to hold the turnbuckle. These threads stripped and the forestay parted." (7



#### HALLELUJAH

Bill Gutzwiller sails *Hallelujah* in the Virgins. She suffered damage from Hugo which took three months to repair. In a recent letter to Paul Peyton, *Suzanne*, he wrote:

"I read with interest your story about thru-hulls in the Winter '89 TOG NEWS. My Tayana is hull 520, three years old. It incorporates the Taiwan teflon/bronze/stainless steel ball valves in sizes 1, 1 1/4 and 1 1/2 inches. While probably better than the old sleeve type seacocks, they are not the answer to every prayer either. Granted that Hallelujah is in warm water twelve months a year, I still had expected to have less trouble with the ball valves. Actually my problems seem to center on those seacocks serving the galley sink drain, and the head discharge. When closed, crud seems to build up on both the inside and outside stainless surfaces of the ball, making it difficult the valve. Most recently I broke off the operating shaft of the seacock serving the galley sink by forcing the turning action too much. To see if it might have longer life, I installed a heavy duty plastic ball valve purchased at a local hardware store. This has all the rubbing surfaces made of plastic and possibly may discourage buildup of foreign material better than on the Taiwan stainless ball. It's too early to tell whether it will provide longer life.

As for prolonging the the life of the original ball sockets or any others for that matter, all I can suggest is regular operation to clear deposits before they get out of hand, making sure the seacock is fully open when in use to eliminate any ball surface area for deposits, and not to let anything except clear liquids get to the seacocks when they are closed.

With regard to the special tool you made to aid in removing your seacocks, it occurs to me that there must be a standard tool of some kind that the boatyards use to insert and tighten the thru hulls initially. I wonder how one gets his hands on these tools. Probably making one's own tool is easier in the long run."

Editors note: As if by magic the following letter from Gary Coit, Spirit of Pipit, arrived soon after the above letter with an answer to Bill Gutzwiller's question:

"There is a tool specifically made for this purpose by, I believe, the Algonquin company (some of their products are sold under the "Buck" brand). The tool is about 6 inches long, with a series of stepped down cylinders of decreasing diameter. There are grooves on opposite sides of each step and a tee handle on the big end. The big end also has flats on opposite sides for gripping with a wrench. Apparently these tools come in two different sizes. Mine is labeled "2" and it fits all the original seacocks on my boat. It worked very well and was quite a bargain for about \$15-20. I replaced all the seacocks with the ITT Jabsco teflon ball product and am very pleased with them. As a minor suggestion, one can put a couple of coats of clear polyurethane on new seacocks, or other bronze fittings, and they'll stay new looking a lot longer."

#### SPIRIT OF PIPIT

In newsletter #45 Tom Beard reported replacing the bobstay fitting bolts with carriage bolts. Gary Coit, Spirit of Pipit (T-37) read Tom's words and has a few comments of his own to add:

"Thinking my fitting had pulled away from the hull a little bit, I removed the two slotted, oval head bolts holding the fitting in place. The boat was in the water and the fitting half under the water. I quickly discovered that it was impossible to remove the bolts with a screwdriver, so I had to resort to using a cold chisel, which I hammered at an angle into the outer edge of the oval heads. Eventually I got the bolts out, but their heads were a mess. And I discovered then that the fitting had not really pulled away from the hull. I replaced the oval bolts with standard hex bolts. I had to file down a part of one bolt head to fit under the bobstay swage fitting, but then was able to install the two bolts in a matter of minutes. And now I can remove them a lot more easily if necessary. The threads of the original bolts were badly damaged. I figured they had been hammered when originally installed to prevent their working loose. Since the bolts entered the hull under my fuel tank, there was no practical way to hammer the threads of the new ones in the same manner, so I've kept a close watch on them ever since, but have detected no loosening. I have no idea whether they are screwed into a steel plate or into a nut embedded in the fiberglass. I do know they held all the way from Greece to Annapolis."

#### FAR AWAY

Ken Green, T-37, hull 243, lives and cruises in Maine. He writes,

"We had a little trouble with our Adler Barbour fridge. The copper pipe that goes from the compressor to the cooler dipped down into below the floorboards and backup again. At the lowest point the pipe corroded probably due to condensation and we lost all our Freon. We replaced the pipe and all is well but I would recommend that anyone having this arrangement paint over the copper pipe to avoid corrosion."

### C oast Guard vs The Josum G

Paul Sheldon, owner of T-37 Josum G, describes his negative experience with the U.S. Coast Guard after an engine failure in Sept. 89: (the following is an abstract of Paul's input)

"A failure occurred in the exhaust pipe just after the exhaust manifold on my Perkins 4-108. Happy is the sailor who carries with him sheet metal high temperature gasket material and hose clamps. Not so happy is the sailor who, under appropriate circumstances, asks for Coast Guard assistance, as explained in the following letter to Admiral Paul Yost, Commandant, United States Coast Guard, Washington, D.C.:

"Sailing from Nantucket to Woods Hole, Massachusetts in 25 knot winds, after suffering an engine failure which filled my vessel with carbon monoxide fumes, I was unable to enter Woods Hole harbor because of foul currents and contrary winds. I put into Tarpulin Cove, protected from northeast winds. With a heavy anchor and chain of sufficient rode, I felt secure, though not comfortable. During the night the winds veered to the east and increased to thirty knots,

sending a nasty swell into the cove. The anchor dragged and I was soon bouncing on rocks at low tide. I was able to row out another anchor and kedge off. Only after taking myself out of harms way did I call the Coast Guard Station, Woods Hole, to inform them of my situation; that I was not in immediate danger, was trying to repair my engine, and did not need assistance. We set up a radio net and I reported my status every hour. Later that afternoon, unable to to complete my engine repairs, and with wind and swell increasing, the two anchors dragged, placing my vessel again on the rocks. I called Coast Guard Station, Woods Hole and declared my emergency situation and requested help. They arrived in short order, surveyed the scene, and advised me that the situation did not warrant their help, and asked me if I had any preference as to the commercial tow service to call. I protested and asked them to float me a line the 150 feet that separated us as I was in grave fear of my vessel's hull breaking open and only wanted to be towed out of harm's way so I could continue to effect my engine

repair. I was advised that it was against Coast Guard policy to render assistance in this situation because of conflict with commercial operators. While the Coast Guard vessel stood by, a commercial tow service was summoned and I was successfully extricated and towed to a safe harbor. I do begrudge the \$525 paid to the towing firm, but not for their services. I wish to inform you, most emphatically, that a drastic dichotomy exists between the stated mission of the Coast Guard and it s actual implementation. I wonder how you would feel if one of your men were injured in the line of duty, and you approached me as a emergency medical specialist asking for help, only to have me state that it was against my policy to do so and ask you if you had any preference as to which commercial ambulance service you wished me to call!"
